## REASONABLE RIGHTS OF PARENTING TIME FOR YOUNG CHILDREN

Age is determined by the <u>OLDEST child</u> on the order. All children shall follow the same parenting time schedule as the oldest child represented in the case.

### FROM BIRTH UNTIL CHILD'S FIRST (1ST) BIRTHDAY

The non-custodial parent shall have two (2) visits per week for three (3) hours each. If the parents cannot agree, parenting time shall be exercised on Tuesday and Thursday from 5:00 p.m. until 8:00 p.m.

The non-custodial parent shall also have three (3) visits per month for six hours each. If the parents cannot agree, parenting time shall be exercised the first three (3) Saturdays of each month from 12:00 p.m. (noon) until 6:00 p.m.

# FROM CHILD'S FIRST (1ST) TO CHILD'S THIRD (3RD) BIRTHDAY

<u>Alternate Weekends</u>: Parenting time shall occur on alternating weekends from Saturday at 10:00 a.m. until Sunday at 6:00 p.m.

<u>Weekday Parenting Time:</u> Parenting time shall occur one time per week from 4:00 - 8:00 p.m. on a day of the week agreed to by the parents. If the parents cannot agree, weekday parenting time shall be exercised on Wednesday.

# REASONABLE RIGHTS OF PARENTING TIME HOLIDAY SCHEDULE FOR CHILDREN UNDER THE AGE OF 3

**Holiday Parenting Time:** The standard Reasonable Rights of Parenting Time Holiday Schedule shall be followed, **except** all parenting time shall occur on the <u>holiday only</u> from 12:00 p.m. (noon) until 8:00 p.m.

### Winter (Christmas) Break:

### Years Ending in ODD #s:

The Father shall have parenting time from December  $23^{rd}$  at 6:00 p.m. until December  $24^{th}$  at 8:00 p.m. The Mother shall have parenting time from December  $24^{th}$  at 8:00 p.m. until December  $25^{th}$  at 6:00 p.m.

#### Years Ending in EVEN #s:

The Mother shall have parenting time from December 23<sup>rd</sup> at 6:00 p.m. until December 24<sup>th</sup> at 8:00 p.m. The Father shall have parenting time from December 24<sup>th</sup> at 8:00 p.m. until December 25<sup>th</sup> at 6:00 p.m.

## **Summer Break:**

<u>Age 1-2</u>: The non-custodial parent shall have one (1) week of parenting time between June 1<sup>st</sup> and August 31<sup>st</sup>.

<u>Age 2-3</u>: The non-custodial parent shall have three (3) non-consecutive weeks of parenting time between June 1<sup>st</sup> - August 31<sup>st</sup>.

Summer parenting time can be taken in any manner selected by the non-custodial parent, as long as it is exercised in one-week increments. The non-custodial parent shall submit a summer parenting time schedule *in writing* to the custodial parent before May 1st of each year, with a copy to the Friend of the Court.
